

 $\ensuremath{\mathsf{MCDR}}$ completed the 5 years plan of upgrading hardware and all security systems.

Custodian banks became direct settlement participants and so one DVP layer is applied between

brokers, custodians and the CSD in the market which substantially reduced liquidity risk, asset commitment risk and counterparty risk.

New executive regulations of the investment law were issued where it obliged issuers to be listed at the CSD and for all issues to use the digital signature service provided by MCDR.
